Section III Hazards Identification

<u>Most important hazards:</u> UP&EZ! is an odorless white powder. Contact can cause irritation to eyes, skin, respiratory system, and gastrointestinal tract.

Specific hazards:

Eyes – Contact can cause severe irritation or burning of the eyes, including permanent damage. *Skin* – Contact can cause severe irritation or burning of the skin, especially in the presence of moisture. *Ingestion* – This product can cause severe irritation or burning of the gastrointestinal tract if swallowed. *Inhalation* – This product can cause irritation of the respiratory system. Long-term exposure may cause permanent damage.

<u>Medical conditions aggravated by exposure:</u> Contact may aggravate disorders of eyes, skin, gastrointestinal tract, and respiratory system.

Section IV First Aid Measures

<u>Skin contact:</u> Wash with mild soap and water. Remove severely contaminated clothing and clean before reuse. Seek medical attention in the event that irritation occurs.

Eye contact: Flush thoroughly with large amounts of water. Seek medical attention if irritation persists.

Ingestion: Rinse mouth with water, give subject water to drink and do not induce vomiting. Seek medical help.

Inhalation: Remove to fresh air and get medical help for any breathing difficulties.

Section V Fire Fighting Measures

<u>Fire hazards:</u> Dust can form an explosive mixture in air. Avoid dust formation and take precautionary measures against static discharges. Sources of ignition should be kept well clar.

Hazardous combustion products: none

Extinguishable media: Use dry chemical fire extinguisher or water.

<u>Fire fighting instructions:</u> Keep personnel away from and upwind of fire. Wear full fire-fighting turn-out gear (full Bunker gear), and respiratory protection (SCBA).

Section VI Accidental Release & Disposal Measures

<u>Personal precautions</u>: NIOSH approved dust respirator suggested. Approved dust respirators are required when dust exceeds recommended TLV. Safety glasses with side shields or goggles are suggested. Cloth, leather, rubber, or plastic gloves are recommended.

<u>Environmental precautions</u>: Provide an adequate exhaust system that is filtered to avoid contaminating the environment, and that meets the TLV requirements in the work area.

<u>Disposal</u>: Vacuum or scoop up spilled material and dispose in an appropriate waste container. Misting with water or absorbent dust control products may help to keep airborne dust levels at a minimum. Provide proper ventilation and personal protection equipment for use during clean-up. Waste material can be buried in an approved landfill in accordance with Federal, State, and Local environmental regulations. According to 40 CFR, Part 261 of the Resource, Conservation, and Recovery Act (RCRA), this product is not classified as a hazardous material.

Spill/leak procedure: Use proper protective equipment.

<u>Small spills:</u> Use dry method to collect spilled materials. Avoid generation of dust. Do not clean up materials with compressed air. Store collected materials in dry, sealed plastic or metal containers. Residue on surfaces may be washed with water.

<u>Large spills</u>: Use dry methods to collect spilled materials. Evacuate area downwind of clean-up operations to minimize dust exposure. Store spilled materials in dry, sealed plastic or metal containers.

<u>Containment:</u> For large spills, as much as possible, avoid the generation of dusts. Prevent release to sewers or waterways.

<u>Cleanup:</u> Residual amounts of material can be flushed with large amounts of water. Equipment can be washed with water.

Section VII Handling and Storage

<u>Handling</u>: Keep in tightly closed containers. Protect containers from physical damage. Avoid direct skin contact with the material.

Storage: Store in cool, dry, and well-ventilated location. Do not store near incompatible materials. Keep away from moisture.
